**Refining Corporate Membership** Annual Fee US\$ 450  
Any firm or corporation engaged in cane sugar refining.

**Allied Corporate Membership** Annual Fee US\$ 450  
Any firm, corporation, partnership or proprietorship engaged in a business of supplying goods or services to the Cane Sugar Refining Industry, or engaged in cane milling, beet sugar manufacturing, corn sugar manufacturing and societies of these industries.

**Associate Membership** Annual Fee US\$ 40  
Any employee of a Corporate Member.

**Affiliate Membership** Annual Fee US\$ 60  
Any person interested in the Cane Sugar Refining Industry, excepting those persons engaged in the supplying goods and services to the Cane Sugar Industry as a self employed person, as a member of a partnership, or as an employee of a firm or corporation so engaged.
